We have been approached by a handful of organizations requesting that we work with them in Simulated Emergency Test-like scenarios like a lost person, search and rescue, setting up backbone communications, etc.

In regards to updating the bylaws, the Bylaws Committee indicated to Bob Cordell KBØGIP that they will meet and should have some ideas by the October General Meeting.

We are looking for more VE's, especially General class and higher.
