


Anoka County Radio Club General Meeting Minutes

Amateur Fees Date NOT YET ESTABLISHED, Sat, 20 Mar 2021:

Apparently, there is misinformation concerning a noticed published by the FCC yesterday. This notice did not set the effective date for license fees. While It is anticipated the effective date will be this summer sometime the FCC will announce the date in advance. Below is from a message the ARRL's attorney sent to the Officers and Directors of the ARRL on the subject. -- **Bill Lippert AC0W, Director Dakota Division**

The FCC fees Report and Order adopted last December was published in this morning's Federal Register. I want to note to everyone that although generally the rules take effect on April 19, collection of the amateur fees will NOT begin on that date. The effective date for new amateur radio fees has not yet been established. The FCC explicitly states in the published Notice (at p. 15061, para. 44, https://tinyurl.com/y52ff2zy) that the fees "will not take effect until the requisite notice has been provided to Congress, the FCC's information technology systems and internal procedures have been updated, and the Commission publishes notice(s) in the Federal Register announcing the effective date of such rules." I expect that the effective date will be some time this summer, but in any event we will have advance notice. -- David R. Siddall, Managing Partner, DS Law, PLLC
